GIST OF THE PROCEEDINGS OF THE $50^{\text {TH }}$ ANNUAL GENERAL MEETING ("AGM") OF THE MEMBERS OF AYUSHMAN INFRATECH LIMITED. HELD ON FRIDAY, SEPTEMBER 29, 2023 AT 12:00 P.M. AT THE REGISTERED OFFICE AT DSC-319, DLF SOUTH COURT, SAKET, NEW DELHI-110017.


Mr. Vinay Anand, Company Secretary and Compliance Officer of the Company started up the opening remarks for the commencement of $50^{\text {th }} \mathrm{AGM}$ of the Company and welcome all the Shareholders, Directors and Auditors of the Company to the $50^{\text {th }} \mathrm{AGM}$ of the Company.

Thereafter, the he introduced other Board Members participating in the AGM starting from Mr. Manoj Agarwal, Director and Chairman for the Board and General Meetings of the Company, Mrs. Pragya Agarwal, Managing Director followed by Mr. Mayank Agarwal, Director \& CFO, Mr. Lalit Kumar, Independent Director \& Chairman of the Audit Committee \& Nomination and Remuneration Committee, Mr. Rajveer Singh, Independent Director of the Company.

He also acknowledged the presence of Mr. Pramod Kumar Narula, Partner of M/s. P. K Narula \& Co., Statutory Auditors, Mr. Narendra Thakur, Secretarial Auditor and Mr. Abhinav Agarwal Authorised Representative of M/s. A Abhinav \& Associates, Scrutinizer participating therein.

The Chairman then took up the formal proceedings of the AGM by mentioning the certain regulatory guidelines and procedure regarding participation in the meeting.

He stated that as per the applicable provisions of the Companies Act, 2013 and rules framed thereunder, the Company had provided the facility, to the Members, to cast their vote electronically (remote e-voting) on CDSL e-voting platform in respect of all the businesses mentioned in the Notice dated August $31^{\text {st }}, 2023$. The e-voting commenced at 9.00 am (IST) on Tuesday September 26, 2023 and ended at 05.00 pm (IST) on Thursday September 28, 2023. He drew attention of the Members that at the end of the discussions on the resolutions, Members present at the meeting and who have not cast their votes by availing the remote e-voting facility, can exercise their vote at the AGM itself.

The Board of Directors had appointed $\mathrm{M} / \mathrm{s}$. A Abhinav \& Associates, Scrutinizer Company Secretaries, as the Scrutinizer for the purpose of scrutinizing both, the remote e-voting and voting at the Meeting, in a fair and transparent manner.

The Chairman further informed that the voting rights shall be in proportion to the shareholding of the Members as on the cut-off record date i.e. September 22, 2023.

The Notice convening the $50^{\text {th }}$ AGM dated August $31^{\text {st }}$, 2023, along with the Annual Report and Auditors Reports which was sent to the members by email and public notice published in the newspapers were taken as read.

The Chairman informed that the Auditor's Report on the Standalone financial statements of the Company for the financial year ended March 31, 2023 does not have any qualification or observations or comments on financial transactions or matters which have any adverse effect on the functioning of the Company. In view of the same, the Auditors' Report and the secretarial auditors report is not required to be read out before the meeting, as provided in the Companies Act, 2013 and taken as read.

The Chairman then informed that Members, who had not cast their vote electronically, to cast their votes at the AGM itself by following the procedure mentioned in the notice.

The Chairman thereafter explained the resolutions to be voted at the Meeting.

Thereafter the Chairman announced the voting to commence and the Members could cast their votes, who had not voted earlier.

I, Abhinav Agarwal, Company Secretary in Practice and the Proprietor of $\mathrm{M} / \mathrm{s} \mathrm{A}$ Abhinav \& Associates bearing membership No. 11894 and COP No. 17590, have been appointed by the Board of Directors of Ayushman Infratech Limited (Formerly Known as Shantnu Investments (India) Limited) ("the Company") as the Scrutinizer for the purpose of scrutinizing the process of voting through electronic means ("Remote E-voting") on the resolutions contained in the notice dated $31^{\text {st }}$ August, 2023 during the period from Tuesday, $26^{\text {th }}$ September, 2023 (9:00 A.M. IST) to Thursday, $28^{\text {th }}$ September, 2023 (5:00 P.M. IST) and voting process through Ballot conducted during the $50^{\text {th }}$ AGM ("Voting") of the Company held at the Registered office of the company at DSC-319, DLF South Court, Saket New Delhi110017 in a fair and transparent manner and ascertaining the requisite majority on voting through Remote E-voting and voting carried out at the AGM pursuant to the provisions of Section 108 of the Companies Act 2013 ("the Act") read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (the "Rule") as amended from time to time and Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (the "SEBI Listing Regulations") and Circular Nos. SEBI/HO/CFD/CMD2/CIR/P/2022/62 and SEBI/HC/CFD/PoD-2/P/CIR/2023/4 dated May 13, 2022 and January 5, 2023 ("Applicable Circulars") respectively issued by Securitiess and Exchange Board of India ("SEBI").

## I, submit my report as under:

1. The Notice of the AGM along with the Annual Report for FY 2022-23 was sent only in electronic mode by the Company to Members whose E-mail IDs were registered with the Company's Registrar \& Share Transfer Agent /Depository Participant(s).
2. The Company had also advertised in the newspapers, asking those members who have not registered their email id to do so and to the extent, details provided by the shareholders were considered for sending the Notice of the AGM. The Notice calling the $50^{\text {th }}$ AGM has been uploaded on the website of the Company at http://www.ayushman.net.in. The Notice can also be accessed from the website of the Stock Exchanges i.e. Metropolitan Stock Exchange of India Limited (MSE) at https://www.msei.in// respectively and on the website of Central Depository Services (India) Limited (agency for providing the Remote E-Voting facility) i.e. on https://www.evotingindia.com//.
3. The Company had appointed Central Depository Services (India) Limited (CDSL) ( "Service provider"), for the purpose of extending the facility of Remote E-voting to the Members of the Company.
4. Skyline Financial Services Private Limited are the Registrar and Share Transfer Agent ('RTA') of the Company.
5. The Service Provider had provided a system for recording the votes of the Members voted electronically through Remote E-voting on all the items of the business (Ordinary businesses) sought to be transacted in the $50^{\text {th }}$ AGM of the Company, which was held on Friday, 29 ${ }^{\text {th }}$ Day of September, 2023.
6. The Service Provider had set up electronic voting facility on their website https://www.evotingindia.com//. The Company had uploaded all the items of the business to be transacted at the AGM on its website and also on the website of Service Provider and also on the website of Stock Exchange Viz. Metropolitan Stock Exchange of India Limited at https://www.msei.in// to facilitate their members to cast their vote through Remote E-Voting.
7. The cut-off date for the purpose of dispatch of notice of the AGM to shareholders of the Company holding shares either in physical form or in dematerialized form was $01^{\text {st }}$ September, 2023.
8. The Company completed the dispatch of the notices by email to the members by $05^{\text {th }}$ September, 2023.
9. The Cut-off date for the purposes of identifying the Members who will be entitled to vote on the resolutions placed for approval of the Members was Friday, $\mathbf{2 2}^{\text {nd }}$ September, 2023 and as on that date, there were 89 Shareholders of the Company.
10. As prescribed in the aforesaid Rules, the Remote E-voting facility was kept open for 3 (three) days from Tuesday, $26^{\text {th }}$ September, 2023 at 9:00 A.M. (IST) to Thursday, $28^{\text {th }}$ September, 2023 at 5:00 P.M. (IST).
11. The Management of the Company is responsible for ensuring compliance with the requirements of the Act and the Rules made there under and SEBI Listing Regulations relating to Remote E-voting and voting carried out in AGM on the resolutions contained in the notice calling the AGM. My responsibility as the Scrutinizer for Remote E-voting process was restricted to making a Scrutinizer's Report of the votes cast "in favour" or "in against" the resolutions contained in the Notice, based on the reports generated from the e-voting system provided by service provider of the company.
12. At the end of the voting period on Thursday, $28^{\text {th }}$ September, 2023 at 05:00 P.M, the voting portal of the service provider was blocked forthwith.
13. The members details, such as their names, folios number/ DP ID/Clients ID of shares held, who have casted votes through Remote E-voting, were downloaded from the e-voting website of Central Depository Services (India) Limited (CDSL) https://www.evotingindia.com// in order to ensure that such members did not vote again through ballot paper at the AGM Venue.
14. Two ballot boxes were kept for the ballot paper for the purpose of voting through ballot paper, were locked in my presence with due identification marks placed by me.
15. The locked ballot boxes were subsequently opened in my presence and ballot papers were diligently scrutinized. The ballot papers were reconciled with the records maintained by the Company/ Registrar and Transfer Agents of the Company and the authorizations / proxies lodged with the Company.
16. The ballot papers, which were incomplete and/or which were otherwise found defective have been treated as invalid and kept separately.
17. On Friday, $\mathbf{2 9}^{\text {th }}$ Day of September, 2023, after tabulating the votes casted at the AGM through ballot and through Remote E-voting provided by Central Depository Services (India) Limited was duly unblocked by me as scrutinizer in the presence of Ms. Kajal Grover and Mr. Ridam Gupta who acted as witnesses and were not in the employment of the Company, as prescribed in Sub rule 4 (xii) of the said Rule 20. After unblocking the votes cast, the total votes cast through Remote E-voting and
